

Abuse/Neglect Statute of Limitations

Recently, the statute in West Virginia for nursing home abuse or neglect was shortened from 2 years to 1 year. West Virginia Nursing Home Abuse/Neglect Statute of Limitations Reduced

Earlier this year, the statute of limitations for nursing home abuse or neglect - was cut in half, from 2 years to 1 year. The time limit is measured from the date of death and/or negligence, or the discovery of said negligence.


be lost forever.

Note that this change only pertains to West Virginia cases specifically nursing home neglect and/or abuse. The statute of limitations for traditional medical malpractice has not changed. **Nursing Home Case Venue Change**

Under the new rules, this type of case must be filed in the county in which the negligence or abuse occurred.
