Recipe of the Month

Pumpkin Dump Cake

It's called pumpkin dump cake because you dump, bake, and enjoy it! It is so simple and is the BEST fall cake.



Ingredients:

- 1 (15-ounce) can of pumpkin puree
- 1 (12-ounce) can of evaporated milk
- 3 eggs
- 1 cup brown sugar
- 2 1/2 teaspoons cinnamon
- 1 teaspoon nutmeg
- 1 teaspoon clove
- 1 yellow cake mix (or cake mix of your choice)
- 1 & 1/2 sticks of salted butter, melted
- 1/2 cup crushed pecans (or nuts of your choice)

Directions

1. Preheat the oven to 350°F. Combine the canned pumpkin, evaporated milk, eggs, brown sugar, cinnamon, nutmeg, and clove in a large bowl. Whisk to combine until smooth.
2. Spray a 13-by-9-inch baking dish with cooking spray. Pour the pumpkin mixture into the prepared dish.
3. Sprinkle the cake mix over the top, pressing down lightly. Drizzle the melted butter over the cake mix. Sprinkle nuts on top, if desired, and bake for 50 to 55 minutes.
4. Allow the cake to cool for 15 minutes before serving. Serve warm, topped with whipped cream.

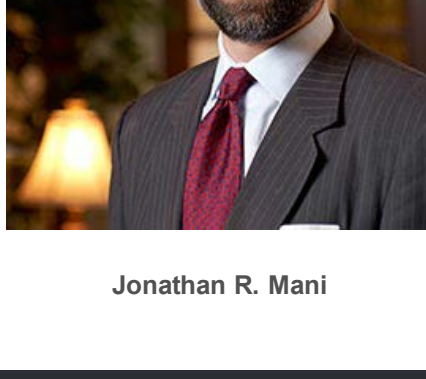

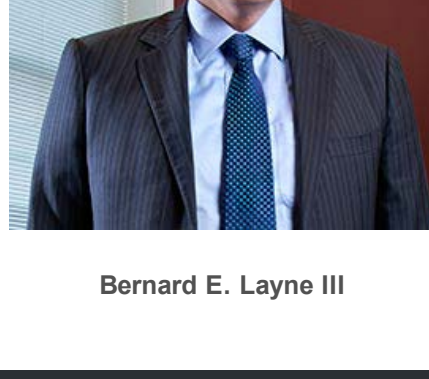

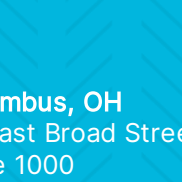
