

# **Basil Soup**

Recipe of the Month

#### This soup makes an easy, creamy, healthy, and hearty dinner. Insanely delicious and comforting.

**Easy Vegan Tomato and**

- 1/2 head onion chopped • 2-3 small garlic cloves 25 oz pureed tomatoes

12 oz water 1 tsp basil dried

1 tbsp olive oil

• 2 tsp salt • 1/2 tsp black pepper ground • 3 cups of tortellini pasta (cooked)

#### 1. Fry the chopped onions in 1 tbsp oil for a few minutes until they turn light brown. 2. Add all the ingredients to a small soup pot. Stir and cover. 3. Cook for 25-30 minutes. Taste while cooking.

- 4. Use a hand blender to make the soup extra smooth and creamy. 5. Add the tortellini pasta and top with a generous amount of chopped fresh basil.


